Climate Risk and Response: Physical Hazards and Socioeconomic Impacts

"How could Earth's changing climate impact socioeconomic systems across the world in the next three decades? Our yearlong, cross-disciplinary research effort provides some answers.

"After more than 10,000 years of relative stability – the full span of human civilisation – the Earth's climate is changing. As average temperatures rise, climate science finds that acute hazards such as heat waves and floods grow in frequency and severity, and chronic hazards, such as drought and rising sea levels, intensify. In this report, we focus on understanding the nature and extent of physical risk from a changing climate over the next one to three decades, exploring physical risk as it is the basis of both transition and liability risks.

"We find that physical risk from a changing climate is already present and growing. Seven characteristics stand out. Physical climate risk is:

"In the face of these challenges, policy makers and business leaders will need to put in place the right tools, analytics, processes, and governance to properly assess climate risk, adapt to risk that is locked in, and decarbonise to reduce the further buildup of risk.

"Much as thinking about information systems and cyber-risks has become integrated into corporate and public-sector decision making, climate change will also need to feature as a major factor in decisions. For companies, this will mean taking climate considerations into account when looking at capital allocation, development of products or services, and supply chain management, among others. For cities, a climate focus will become essential for urban planning decisions. Financial institutions could consider the risk in their portfolios ...

"Auckland residents will soon be able to access more information about the health and safety of their home, with Auckland Council moving to include a *home-fit* check on a property's LIM report.

"The Council has teamed up with the Green Building Council, which offers a *HomeFit Certification*, and from April, that information will be passed to the Council for inclusion on the Land Information Memorandum.

"Joining Kathryn to discuss** the move are Andrew Eagles, Chief Executive of the Green Building Council and Sophie Heighway, Auckland Council's Sustainability Initiatives Manager.

"Our contributing writer Jim Robbins examines the growing calls from scientists and conservationists to protect up to 50% of the earth's land and oceans in the coming decades. Once thought of as unrealistic, many experts are now taking these ideas seriously, not only as a firewall to protect biodiversity, but also to mitigate continued climate warming. Several non-profits have been created by philanthropists, environmental groups, and scientists to buy up vast tracts of land. 'This is not just about saving species, it's about maintaining ecological processes that underpin all life on Earth', says one conservationist.

'Uninsurable and Unhedgeable': Central **Banks Warn of Financial Crisis from Climate** Change

"A future climate disaster, or 'green swan' event, could bring down the global financial system, according to a new report from the Bank for International Settlements (BIS), an international financial organisation which serves as a bank for central banks around the world.

"Like black swan events, 'green swan' events will be very difficult to predict and will hit with little warning. The potential for a cascading series of crises stemming from climate change threatens global financial stability, and the world's central banks are not equipped to respond to them, or even predict what exactly might unfold, the 100-page BIS report said.

"The financial risk from climate change is typically put into two categories: physical risk and transition risk. The former refers to natural disasters or some other climate-related calamity that imposes steep costs on society from physical damage, such as a drought or a hurricane.

"Transition risk refers to the repricing of assets as the global economy shifts towards cleaner energy, such as an oil company losing much of its value following the passage of a painful carbon tax.

Taumata Arowai - Water Services Regulator

"Parliament's Health Committee is calling for submissions on the Taumata Arowai-the Water Services Regulator Bill.

"If passed, this Bill would implement the Government's decision to create a new regulatory body to oversee, administer, and enforce the drinking water regulatory system. The Bill would establish Taumata Arowai-the Water Services Regulator as a new Crown agent and provide for its objectives, functions, and operating principles. It would also provide for its governance arrangements, including the establishment of a board and Māori Advisory Group.

"This Bill is part of a broader package of reforms to the regulatory system for drinking water, wastewater, and stormwater (three waters). The Government has indicated a separate bill will be proposed at a later date to give effect to decisions to implement system-wide reforms to the regulation of drinking water and source water, and targeted reforms to improve the regulation and performance of wastewater and stormwater networks.

Call for Improved UN Sustainable Development Goals Disclosures

"Chartered Accountants ANZ have joined other leading accounting bodies and others calling for corporate and asset owner action and improved reporting on the UN's Sustainable Development Goals (SDG) in an attempt to hit the goals set for 2030. The recommendations are detailed in the report, Sustainable Development Goals Disclosure (SDGD) Recommendations, authored by Carol Adams, Professor of Accounting, with Paul Druckman and Russel Picot, Honorary Professors at Durham University Business School.

"The report has been published by global accountancy bodies: the International Federation of Accountants (IFAC), ACCA, ICAS, Chartered Accountants Australia and New Zealand, the International Integrated Reporting Council (IIRC) and the World Benchmarking Alliance. It is also endorsed by a Director at the UN Development Programme.

"The SDGD Recommendations offer a new approach for all organisations to address sustainable development issues aligned to the three most influential and most used reporting frameworks. They attempt to establish a best practice for corporate reporting on the SDGs and enable more effective and standardized reporting and transparency on climate change, social and other environmental impacts.

Wise Response Society Submission – Crown Minerals Act 1991 Review

In its 27th January submission to MBIE regarding the current review of the Crown Minerals Act 1991, Wise Response among other things suggests the proposed vision for the revised Act 'rests on a number of principles which are neither fundamental nor comprehensive'. They suggest alternate wording which they perceive would achieve that.

Wise Response also says 'Nowhere in these documents are effective strategic tools employed to enable a realistic evaluation of the underlying assumptions of the sector. As a result, they do not allow either the sector or New Zealanders to prepare for the radical upheavals about to impact on our current way of life. Without these tools, the vision and purpose we propose cannot be achieved.

Countdown Trials Produce with Paper Instead of Plastic

- "Countdown will be trialling the sale of produce wrapped in paper rather than plastic as part of a 10-week programme to test the viability of reducing plastic.
- "The trial will see more than a tonne of plastic removed from fruit and vegetables across three Countdown stores in the Auckland region: Ōrewa, Ponsonby and Manukau.
- "The 'Unwrapped' trial kicked off today [10th Feb] More than 800 customers have already provided feedback in store.
- "Plastic produce bags have been removed as part of the trial, along with the "unwrapping" of 68 products that would normally come packed in plastic.

Jonathon Porritt's Inspiring Lifetime Achievement Award Acceptance Speech

- "Delivering an [10 minute] opening address to an Awards audience of more than 600 sustainability, energy and environment professionals, Porritt built on Mary Robinson's keynote speech at the Sustainability Leaders Forum by stating sustainability professionals should be viewed as 'emancipated champions of hope'.
- "Porritt, who received a CBE in January 2000 for services to environmental protection, also claimed 2020 was shaping up as an extraordinary year for climate action that would redefine business attitudes towards sustainability.
- "2020 is an extraordinarily rare inflexion point in the history of humankind', Porritt said. 'New technologies are transforming markets across the world and most of it is about decarbonising the economy.
- "There are converging elements that offer a prospect of authentic hope, which could change things in an astonishingly short time.'
- "Porritt is the second person to receive edie's Lifetime Achievement Award, following from ex-Unilever chief executive Paul Polman in 2019.
- "Specifically, Porritt noted the potential to match the rapid decarbonisation pledged by businesses and governments with a need to 'recarbonise the planet' by investing in nature to act as carbon sinks.
- "He also heralded the work of Greta Thunberg and the climate strikes movement, claiming it was the 'fastest social progressive movement the world has ever seen', and that it wouldn't stop at seven million young people raising their voice for climate action.
- "Finally, Porritt posed a question to the hundreds of businesses in attendance at the Awards.
- "What is the voice of business going to say?' Porritt asked. 'If you're simply going to go along with the kind of ideology orthodox that has dominated the last 30 years, I advise you to keep quiet.
- "If you're going to acknowledge we have to do this as a combination of forces between government, the private sector and civil society and you want your voice to be heard...that's what leadership is going to look like throughout this decade.' ...
