Note: ** Rachel Carson's *Silent Spring* was first published in three serialised excerpts in the *New Yorker* in June of 1962. The book appeared in September of that year and the outcry that followed its publication forced the banning of DDT and spurred revolutionary changes in the laws affecting our air, land, and water. Carson's passionate concern for the future of our planet reverberated powerfully throughout the world, and her eloquent book was instrumental in launching the environmental movement. It is without question one of the landmark books of the twentieth century.

"Can accountants link profit and the fate of our planet? Corporate reporting could help shift us to a low-emissions economy.

"In brief

- Much of the push for businesses to move on climate change has come from investors.
- Taskforce on Climate-related Financial Disclosures guidelines are a framework for reporting how climate risk affects assets.
- A 2019 AASB/AUASB guidance recommends companies with significant climate exposure also report on climate risk in their financial statements.

"In December 2019, chief executive of Goldman Sachs, David Solomon penned an opinion piece in the *Financial Times*, writing there was 'a powerful business and investing case' for the banking giant to take steps to address climate change.

"Goldman Sachs announced it would spend US\$750 billion in financing, advisory services and investments for initiatives which fight climate change, and ruled out financing projects which didn't, such as drilling for oil in the Arctic or developing new coal mines.

"It was a huge moment: a show of support from a business conglomerate that set both government and corporate leaders' tongues wagging.

"Despite – or perhaps because of – the global pandemic, climate change is back on the business agenda, with momentum steadily building locally, too. ...

"Will Steffen, executive director of the Australian National University Climate Change Institute, gave a presentation in 2017 which predicted a world in which the temperature had risen 4 degrees Celsius above pre-industrial levels would have a maximum carrying capacity of about 1 billion people. That's compared to today's population of 7.8 billion.

"If he's right, it's safe to say not many of today's companies would thrive. ... [Long article. The printed version is accompanied by an abbreviated 20 year timeline.]

UK Supreme Court Hears Climate Heathrow Airport Expansion Case

"In February, campaigners claimed a historic victory in the Court of Appeal, which quashed plans for a third runway at Heathrow on climate grounds. The case was brought by litigation charity Plan B and campaign group Friends of the Earth.

"Three appeal judges ruled that government approval of the expansion plan was unlawful because, among other reasons, it failed to consider the Paris Agreement on climate change. To pursue the project, the transport secretary would have to review how it could fit with the country's climate commitments. The transport department accepted the ruling and said it would not appeal.

"In a two-day virtual sitting of the Supreme Court this week [2nd week of October], Heathrow argued the government was not legally required to consider the Paris Agreement.

"At the same time, the airport owners claimed a third runway was compatible with Paris, so a government review would ultimately conclude it could go ahead. ...

"De Kauwe said that if the Supreme Court agrees with the previous ruling the government's airports national policy statement will remain a "zombie policy" until the government reviews it. Without political will, the expansion plans are unlikely to happen, she said. ...

"The verdict is expected in January. ...

"This case is being closely watched by lawyers around the world who want to see how much impact a country's signature to the Paris Climate Agreement has on actual decision-making' Michael Gerrard, an environmental law professor at Columbia University in New York, told Climate Home.

"The ruling by the Court of Appeal seems to give at least some teeth to Paris. The Supreme Court will either cement or pull those teeth', Gerrard said. ...

NZ's Climate-related Disclosures Plan is Good News

"The accounting profession has a significant role to play in supporting businesses with climate-related financial disclosures.

"Chartered Accountants Australia and New Zealand welcomes the New Zealand Government's plan to mandate climaterelated financial disclosures for some organisations....

"Accountants will be able to help organisations make climaterelated financial disclosures

"CA ANZ is a strong advocate for appropriate climate-related disclosures and reporting for decision making.

"This is a world first but a sensible first step for New Zealand. Many jurisdictions are considering how they can implement mandatory climate-risk disclosures.

"The details of the standards the XRB will develop are critical to ensure they will be useful to investors and to avoid boilerplate responses.

"However, as we noted in our submission to the consultation, comprehensive education is absolutely critical to raise awareness and ensure the reporting entities fully understand their climate risks', McWilliams said. ...

New Swedish Grocery to Price Goods Based on Carbon Footprint

"Felix, a Swedish food brand, has opened a climate-conscious store which will guide buyers to make informed decisions when purchasing food items. In the newly opened store, items are priced based on their carbon footprint. To help buyers understand the impact of their choices on the environment, products in The Climate Store will be bought using carbon equivalents currency (CO2e). The store has allocated each customer a weekly budget of 18.9kg CO2e. This means customers will have to choose foods carefully, avoiding options with higher carbon footprints to avoid blowing their budgets.

"Pricing foods based on their climate impact shows the difference between plant-based foods and animal-derived foods. Many of the foods we consume are greatly contributing to the pollution of the environment. Although many people would love to make a difference by avoiding such foods, it's not always clear which items are worse for the planet. Food production is responsible for about one-quarter of the world's greenhouse gas emissions. If customers can be aware of the foods that contribute most carbon, they can make decisions that will help reduce these emissions.

"Few things are as quintessentially English as a stately home. Tourists love them. And they're a guaranteed box office draw, as 'Downton Abbey' and 'Pride and Prejudice' can attest.

"But there's a more disturbing side.

"Many of these country estates are indelibly linked to brutal legacies of slavery and colonialism. And while their grim origins may have been previously overlooked, they're now facing a new level of scrutiny that — amid raging debates over how Britain reckons with its imperial past — has exploded into its own cultural conflict.

Cutting the Grass? Cut it Out!

"We are heading towards summer, and the warmer weather which goes hand-in-hand with fortnightly lawn mowing for lots of New Zealanders. But a number of ecologists are encouraging Kiwis to cut down on cutting the grass.

"William Ray investigates how a 'no-mow' movement might be a win for people, plants, animals – and the climate. ...

"Of course, lawns are mostly grass but there are other plants like forbs, mosses and ferns which will spring up alongside the grasses if they are given a chance.

"Our lawns in Auckland, in particular, are really diverse', Bec says. 'Every lawn will be different and that will be based on whether it's dry or wet, fertile or infertile, sloped or flat, sunny or in the shade.'

"Reducing pollution isn't the only advantage of meadows. Bruce says studies in the United States have found increased numbers and diversity of invertebrates the longer grass is allowed to grow.

"And Bec says that, in turn, is good news for native lizards and birds which eat those bugs.

"There are some good arguments against turning every lawn into a meadow. Long dry grass is a very significant fire risk, so they aren't a good option for places which are droughtprone. Especially near houses.

"Meadows also make good habitat for rats and mice so it's important to keep on top of predator trapping.

"And, of course, we need to keep lawns short in some areas for recreation. It's hard to play backyard cricket if the grass is knee high.

"But probably the biggest barrier is public opinion.

"We've aligned close clipped lawns with care and tidiness', Bec explains. 'It's the way we've decided gardens and urban settings should look.' ...
