Warren Snow – A Remarkable Man



Warren passed away on 7th August as the result of cancer.

"We are deeply saddened to lose our dear friend, mentor & colleague, Warren Snow, who passed away on Sunday morning. Our aroha goes out to Warren's whānau who have lost a father, brother, cousin, uncle, grandfather, husband – Warren is irreplaceable and his parting leaves a

big hole in many people's lives.

- "Warren was our hero. He was a movement builder who started the zero-waste movement in New Zealand and continued to grow the momentum for zero waste throughout his entire life. Along the way, he supported and nurtured so many people to give the best of themselves to the zero waste kaupapa. He worked tirelessly to advance zero waste because he saw zero waste as a way of delivering benefits to both communities and the planet.
- "Warren was smart, incisive & full of empathy. He explained complicated ideas simply & compellingly, he was clear-eyed about greenwash and corporate lobbying tactics and unafraid to call a spade a spade. He put up with a lot of pushback from vested interests, but he never sold out. He was committed to doing right by the planet and he really lived and worked by his principles.
- "We have enormous gratitude for the groundwork Warren undertook to imagine, create & foster the zero waste concept in Aotearoa. Due to his efforts, New Zealand was the first country in the world to adopt a national zero waste policy and Kaitāia hosted the world's first international zero waste conference. He was a founder of many organisations which are pivotal to zero waste and circular economy advocacy today, including Zero Waste International Alliance, Envision, the New Zealand Product Stewardship Council, the Kiwi Bottle Drive (to name just a few!). Recently, we read reports about zero waste which Warren authored over 20 years ago. The parallels with zero waste and circular economy reports today are striking. Warren was ahead of his time and gifted us a whole lexicon, language and conceptual framework to talk about zero waste, and a network of organisations from which to explore and share zero waste advocacy.

UN General Assembly Votes Recognises Rights to a Healthy Environment

- "The UN General Assembly has almost unanimously voted on a motion to recognise a human right to a clean, healthy and sustainable environment. Resolution A/76/L.75. was sponsored by Costa Rica, Maldives, Morocco, Slovenia and Switzerland.
- "A total of 161 countries voted in favour and no country voted against the resolution, but eight countries abstained including Russia and China.
- "The co-proponents of the draft resolution opted for a technical approach, with the focus on the recognition of the right, building on the resolution of the Human Rights Council, she said, noting the final draft is a strong, well balanced text linking human rights, environment and 'development language.
- "The passing of the measure has been hailed by environmental interests. The Centre for International Environmental Law said it was an historic victory for humanity is more than fifty years in the making.
- "A representative of New Zealand acknowledged the need to take a human rights-based approach to climate change, drawing attention to indigenous peoples' relationship with the environment and the benefits their perspectives can bring to the framing of this proposed human right.
- "The UN Secretary-General António Guterres said this landmark development demonstrates Member States can come together in our collective fight against the triple planetary crises of climate change, biodiversity loss, and pollution. The international community has given universal recognition to this right and brought us closer to making it a reality for all.
- "Mr Guterres said the resolution will help reduce environmental injustices, close protection gaps and empower people, especially those that are in vulnerable situations, including environmental human rights defenders, children, youth, women and indigenous peoples. The resolution will also help States accelerate the implementation of their environmental and human rights obligations and commitments.

Blueprint for More Resilient Communities

"NZ Government releases climate adaptation plan.

- "For the first time Aotearoa has a long-term strategy to deal with the effects of climate change, but the [NZ] government plan released today [4th August] contains few answers to some of the toughest questions including who pays for what.
- "The 200-page National Adaptation Plan shows the priorities for the next six years and pulls together into one place all government efforts to adapt to the warming globe.
- "A priority is to embed climate resilience in all government strategies and policies, the plan says.
- "Despite the draft version asking for public input on the toughest questions of all – for example, who will pay for damage and the cost to adapt to climate change; and how to fairly require people to leave their homes – this final version includes no definitive answers.
- "Instead, it says the massive Resource Management Act reform under way, and expected sometime next year, will be the primary driver in a number of areas including managed retreat.
- "On managed retreat getting some communities out of harm's way in places where it is no longer viable to live – the plan says legislation will also be needed.
- "It reiterates costs will be shared between homeowners, local and central government, insurance companies and banks.
- "It also wants to make sure homes and infrastructure are built away from harm.
- "The plan will see Treasury and Waka Kotahi integrate adapting to climate change into decision making.
- "It also pledges to work with Māaori on climate actions; establish an online one-stop-shop for information on adaptation; a rolling programme of targeted guidance; and a 'programme of work to unlock investment in climate resilience'.
- "The plan says no two communities will experience climate change in the same way, and the government has pledged equity will be at its core.
- "The first three years of the plan are key for both collecting the data and information and starting long-term programmes.
- "The plan is essentially a guide for local authorities, business and individuals to what the Government sees as the priorities.
- "It identifies 43 priority risks which Aotearoa faces from climate change as well as the risk to the telecommunications network. ...

Petition to Reduce Emissions in a Fair Way Using Carbon Quotas

"There are two overarching issues in dealing with climate change, ensuring we reduce emissions, and doing it fairly.

"Certainty of emissions reduction can be achieved by reducing the use of fossil fuels in a planned way. A quota system has been developed to do this as fairly as possible. It's called Tradable Energy Quotas (TEQs) which involves issuing quotas to everyone and making the quotas tradeable.

"As everyone is involved, this approach encourages everyone to be creative and help make this transition away from fossil fuels.

"A petition has been developed to get this system implemented in NZ has been initiated through the Parliamentary website. The petition of 'Deirdre Kent on behalf of Degrowth Aotearoa New Zealand (DANZ): Investigate rationing fossil fuel use with Tradable Energy Quotas' The Petition calls on:

'the House of Representatives investigate an energy rationing scheme such as Tradable Energy Quotas (TEQs), which we believe could address both potential shortages of fossil fuels and the climate emergency.'

How to Make ESG Real

"The 'how' of a company's environmental, social, and governance (ESG) proposition starts with recognising what companies should be solving for: maintaining and reinforcing their social license to operate, in the face of rising externalities. Rising scrutiny of how companies address ESG means a robust approach is more critical than ever, irrespective of whatever name one may choose to give to the attempt to address these externalities, whatever contours one may define for them at a given point, and whatever organisational or governance construct one may put in place for them. Indeed, we believe one may be agnostic to the term ESG but not to its underlying concerns.

"Not all aspects of 'E', 'S', and 'G', however, are priorities for all companies, and it is unrealistic to expect companies do not have to make hard trade-offs within and among ESG dimensions, or that they can lead on every topic. It is therefore instructive to observe companies which approach ESG in a rigorous, strategy-driven, socially attuned way. We call these organisations 'forward-looking companies'. They make ESG intrinsic to their strategy by defining, implementing, and refining a carefully constructed portfolio of ESG initiatives which connect to the core of what they do. Forward-looking companies also contribute to a competitive landscape where good corporate citizenship is marshalled against existential challenges, not least – but not only – climate change.

"When a company determines the dimensions of ESG where it wishes to be good and where it wishes to be excellent, it is making important decisions, with broader second- and thirdorder consequences. Forward-looking companies approach ESG decisions by seeking to gain a deep, evidence-based understanding of their own business and its broader potential effects. The ESG practices of today's large companies generally cluster along three levels of ambition [Long article.]

River Cleanups Move to the Next Level Using Grasses and Oysters

"Philadelphia-based journalist Katherine Rapin reports on efforts to help clean up the Delaware River and other U.S. waterways by restoring them from the bottom up using aquatic grasses and mussels and oysters. As Rapin explains, scientists and conservationists are planting turtle grass and reintroducing mussels in once heavily polluted parts of the Delaware, relying on these organisms to filter pollution and create a strong foundation for a healthy ecosystem. Similar efforts are underway from New York to Florida to California, all complementing the larger fight to reduce nutrient pollution from fertilisers and sewage.

Is the Climate Crisis a Population Problem or a Poverty Problem?

"People don't cause climate change, lifestyles do.

- "On 8th November, according to the United Nations, Earth's population will pass 8 billion for the first time on its way to 10 billion half a century from now. It seems obvious every one of those individuals will need water, food, shelter, clothing, and transportation, and that fulfilling each of those needs comes with a carbon footprint.
- "But once you crunch the numbers, the carbon impact of more people is anything but clear. Researchers have come to realise the population of our planet is far less important than how we live upon it. Fertility rates and carbon emissions are not spread evenly across the globe – any discussion around population growth comes tangled in centuries of colonialism, prejudice, and inequality.

"To hit emissions targets, should we counterintuitively loosen our fixation on counting carbon (and people) and instead prioritise development and climate justice?

From Climate Denial to Greenwashing

"Russel Norman, 2nd August. 17 min read.

- "I have spent decades of my life as a climate activist fighting various deliberate forms of climate science denial propagated by climate polluting companies and their allied political parties, politicians, lobby groups and commentators. The good news is that we have mostly won that battle. The bad news is that they have a new tactic, greenwashing, which is now a major obstacle to progress on climate change. Greenwashing is when businesses or politicians give a false impression, or spin, on their products or policies to give the impression they have a positive impact on the environment when they don't. We now face a new landscape in which even oil companies claim to be doing their bit for the climate with 'carbon offsets' and '2050 net zero goals'. Their aim is to stop real action on climate by making people think it is all under control.
- "One of the jobs of the government is to sort out the real climate actions from the greenwashing, to hold industry to account. And of course, one of the jobs of the government is to not engage in greenwashing themselves. The problem with some of the actions of the current [NZ] government is rather than holding business to account for its greenwashing, on some vital climate issues the government is actually a proponent of greenwashing.
- "This greenwashing is closely linked to a wrong-headed theory of change which we hear repeatedly There are fundamental conflicts in the climate policy space – some industries will not accept they need to cut emissions. The attempt to gloss over these conflicts and seek consensus means the government adopts policies which the polluters will accept, and which consequently do not cut emissions. This policy outcome is then sold to the public as a great victory when in truth it is a defeat – it is greenwashed.

ESG Should be Boiled Down to One Simple **Measure: Emissions**

"Three letters that won't save the planet

- "If you are the type of person who is loth to invest in firms which pollute the planet, mistreat workers and stuff their boards with cronies, you will no doubt be aware of one of the hottest trends in finance: environmental, social and governance (ESG) investing. It is an attempt to make capitalism work better and deal with the grave threat posed by climate change. It has ballooned in recent years; the titans of investment management claim more than a third of their assets, or \$35trn in total, are monitored through one ESG lens or another. It is on the lips of bosses and officials everywhere.
- "You might hope big things would come from this. You would be wrong. Sadly those three letters have morphed into shorthand for hype and controversy. Right-wing American politicians blame a 'climate cartel' for soaring prices at the petrol pump. Whistleblowers accuse the industry of 'greenwashing' by deceiving its clients. Firms from Goldman Sachs to Deutsche Bank face regulatory probes. As our special report this week concludes, although ESG is often well-meaning it is deeply flawed. It risks setting conflicting goals for firms, fleecing savers and distracting from the vital task of tackling climate change. It is an unholy mess which needs to be ruthlessly streamlined. ..

"It is better to focus simply on the e. Yet even that is not precise enough. The environment is an all-encompassing term, including biodiversity, water scarcity and so on. By far the most significant danger is from emissions, particularly those generated by carbon-belching industries. Put simply, the e should stand not for environmental factors, but for emissions alone.

- According to the Report, cascading and interlinked crises are putting the 2030 Agenda for Sustainable Development in grave danger, along with humanity's very own survival. The Report highlights the severity and magnitude of the challenges before us. The confluence of crises, dominated by COVID-19, climate change, and conflicts, are creating spin-off impacts on food and nutrition, health, education, the environment, and peace and security, and affecting all the Sustainable Development Goals (SDGs). The Report details the reversal of years of progress in eradicating poverty and hunger, improving health and education, providing basic services, and much more. Has the UK's TCFD Mandate Improved **Corporate Climate Reporting?**

"Published late last week [last week of July 2022], the FRC and FCA's findings indicate, while most businesses are technically complying with the mandate, many still have a long way to go before producing a meaningful and high-guality report which covers all key aspects of the framework laid out by the Taskforce on Climate-Related Disclosures (TCFD).

- "The UK Government mandated TCFD-aligned annual reporting for around 1,300 large organisations back in April, in a global first.
- "The FCA found not all of these companies were actually meeting the TCFD's full recommendations in these fields, despite self-reporting as having done so.
- "Across the board, the FCA is warning there is much to be done to improve reporting quality. The most common reporting gap was found to be scenario analysis.
