Microhome Village Ends Homelessness for Hundreds

- "It's billed as the country's only master-planned development for people coming out of homelessness. Residents call it the best neighbourhood they've ever lived in. ...
- Nearly 350 individuals formerly experiencing homelessness reside in the village, which provides permanent housing and sits just outside Austin's city limits As of March, the village's retention rate for residents is about 88%. Through a series of new investments, Community First plans to soon triple its footprint.
- "The community itself generated \$1.2 million last year through various micro-businesses MLF has established in the village, employing a number of its residents in the process. ...
- "Each microhome has a bed, fridge and microwave but not a kitchen or a bathroom; those residents use communal outdoor kitchens, as well as bathrooms and showers which individually lock, located in hubs near the microhomes.

Social Power: The Twelve Habits of Successful Change-makers

"The Social Change Project sought to answer one critical question:

What can we learn about how social change is happening today that can strengthen civil society's future efforts?

"Over 18 months, around 400 change-makers took part in a conversation which identified the ways of thinking and behaving which characterise successful examples of change. These behaviours or 'habits' were exhibited by charity campaigners, local activists, service providers, and parents fighting for their children's rights. We found them in organisations of all sizes and types. People from all walks of life, with all kinds of goals, who are all working to make something better.

- "We shared what we learned in the Social Power report, which urges civil society to unleash its 'social power' by being bolder and braver.
 - 1. Mission first, not model or money
 - 2. Looking at the bigger picture (whole-systems approach)
 - 3. Being adaptive and responsive
 - 4. Persistence, perseverance and resilience
 - 5. In whose name?
 - 6. Primacy of relationships
 - 7. Understanding other people's interests and motivations even when it makes us uncomfortable
 - 8. Radical listening and an asset-based approach
 - 9. Collaborating rather than competing
 - 10. Knowing our tools
 - 11. Evaluating what matters and learning from it....
 - 12. Taking Responsible Risks....

Businesses Call for Nature Impact Disclosures to be Mandatory by 2030

- "More than 300 businesses, including H&M, Sainsbury's and Nestlé, have urged world leaders to make it mandatory for companies to assess and reveal their impact on nature by 2030.
- "Businesses and financial institutions in 56 countries including the UK, Canada and China - are pushing for governments to agree to the disclosures at Cop15, the UN biodiversity conference being held in Montreal this December.
- "In an open letter to heads of state, business leaders said the business and financial status quo was 'economically shortsighted and will destroy value over the long term'.
- "If agreed, the pledge would apply to all large companies across the 196 countries signed up to the Convention on Biological Diversity, the global agreement on protecting nature. It follows increases in the number of companies making pledges to reduce emissions, with climate disclosures now mandatory in the UK, France and New Zealand, and pressure mounting for other countries to take action.
- "The firms, which have combined revenues of more than \$1.5tn (£1.3tn) have agreed to assess their impacts on nature, disclose that information and publicly commit to reducing their negative effects. If parties don't agree to make these disclosures mandatory, they will be voluntary.
- "The open letter was released alongside a report published by Business for Nature, the Capitals Coalition, and CDP, a nonprofit specialising in environmental disclosure systems. 'They know there can be no business on a dead planet', the report says. 'They stand ready to transform their businesses and are calling on governments to set the rules of the game through legislation that will create fair competition for business."
- "Scientists say the biodiversity crisis is as serious as the climate crisis, with an estimated 1 million species at risk of extinction, yet there is less information about how businesses affect biodiversity because this data is not being disclosed. More than 18,600 companies worldwide disclosed data about their impact on climate via CDP in 2022, yet just over 1,000 firms disclosed data on forests - and 4,000 on water security - according to the report.

- "A strong performance in the newly established QS Sustainability rankings of universities globally announced today has earned University of Auckland, a top ten ranking from the two main organisations assessing universities for their progress towards sustainability.
- "In the inaugural Quacquarelli Symonds (QS) Sustainability rankings released today, the University has earned tenth place in the world. QS.....
- "Earlier this year, the University was ranked sixth in the 2022 THE (Times Higher Education) University Impact Rankings, which assess universities against the Sustainable Development Goals. Having held the top place for the first two years of this ranking,

- "In general, companies failed to disclose the relevant quantitative climate-related assumptions and estimates used to prepare the financial statements, even when they indicated that climate risks may impact these assumptions.
- "Companies did not present consistent climate narratives. Their financial statements failed to fully reflect climate considerations included in the companies' other reporting.
- "There was little evidence auditors considered the impact of material climate-related matters.
- "No company used assumptions and estimates which were aligned with achieving net zero by 2050 or sooner. This was despite a significant majority of companies having targets or ambitions to achieve this drive.

Less Cooling Needed with this White Paint

- "A stunningly white paint could be used to reduce reliance on air conditioning, after it was demonstrated to reflect 98.7% of incoming sunlight.
- "In demonstrations it was shown to keep surfaces 9.5°C cooler than the surroundings by completely reflecting incoming solar radiation.
- "In 2021 Xiulin Ruan, a Purdue University professor of mechanical engineering, first developed the paint, and with a new tweak it's achieved the same results with a thinner coat, which the potential of becoming an industry standard.
- "The hexagonal structure reflects the sunlight more totally, and the paint also incorporates voids of air which make it highly porous on a nanoscale. This lower density, together with the thinness, provides another huge benefit: reduced weight.
- "The newer paint weighs 80% less than barium sulphate paint vet achieves nearly identical solar reflectance, which Ruan says opens the door to whole new domains of commercial application.... ultra-white paint reflects the sun's rays entirely, sending the thermal energy outside the atmosphere

It is Possible for Nations to go 100% Organic

- "Jacinda Ardern once told the United Nations 'We are determined to show we can be the most sustainable food producers in the world'. But, when she made that promise in 2019, the title was already taken, and is still firmly held by a state in northeast India, called Sikkim.
- "Every single one of Sikkim's 66,000 farms is organic, free from agrichemicals and synthetic fertilisers, which are banned. The Sikkim Government is the first government in the world to achieve its vision of 100% certified organic farmland state-wide.
- "As we grapple with the climate, water and biodiversity crises, learning from Sikkim's success has never been more important. Sikkim is proof that with concerted effort, it's possible to ditch industrial agriculture and its destructive addiction to agrichemicals and synthetic fertilisers, and shift to regenerative organic farming, which works with nature rather than against it.
- "It wasn't something which happened overnight. It didn't happen because Sikkim's shoppers suddenly decided to buy organic food or because its farmers woke up one day and decided to switch to organic with no support. It happened because the Sikkim Government used policies, public investment and a transition plan to make it happen.
- "New Zealand has had far more resources at its disposal. However, despite Ardern's promise that our agriculture sector would become 'sustainable', this government has been heavy on the greenwash and light on the action.

2022 Scorecard on Insurance, Fossil Fuels and the Climate Emergency

"Insurance company restrictions on oil and gas are finally starting to catch up with those on coal, according to new data from the Insure Our Future campaign. Ahead of COP27, the campaign coalition argues insurers must now fully exit new coal, oil and gas, and demonstrate the industry is ready to deliver on its net zero commitments.

"Insure Our Future's annual scorecard ranks the top 30 global fossil fuel insurers on the quality of their fossil fuel exclusion policies. This year Allianz, AXA and Axis Capital rank best for their coal exit policies, while Aviva, Hannover Re and Munich Re come out on top for their oil and gas exclusions.

- "At the bottom of fossil fuel rankings are a group of insurers which have yet to adopt any restrictions on providing cover to coal, oil or gas projects, including US insurers Berkshire Hathaway and Starr and Bermudian carrier Everest Re. The UK's Lloyd's of London also scores very poorly, having announced a coal exit framework in 2020 but then backtracked by declaring it optional.
- "Liberty Mutual, Chubb and Tokio Marine have adopted some restrictions on coal but actively insure the expansion of the oil and gas industry. Chinese insurers PICC and Sinosure have not adopted any fossil fuel restrictions but, following Chinese government policy, will no longer cover new coal power plants overseas.

Why Investors Now Want Companies to Disclose Plastic Pollution Risk

Outlines plastic pollution. Posits a virgin plastic tax or extended producer responsibility fees to help cover the cost of collection and safe disposal. Refers to CDP expanding its global environmental disclosure system, which currently asks companies to report their climate, forests, and water risk, to in addition extend those to the plastic pollution problem by building on existing reporting frameworks.

2022 CFO Sustainability Snapshot Survey

"The transition to a more sustainable economy continues to impact organisations.

- "This 'snapshot survey' of New Zealand CFOs provides insights on the progress of their organisations, how they see their role, their contributions as CFOs and barriers to progression. Last year in our inaugural CFO Sustainability Snapshot Survey, we reviewed the current state.
- "As was the case in 2021, the 2022 survey confirmed the view CFOs are well-positioned to take a leadership role in driving timely and effective sustainability transitions, given risk management and value creation are core to their role. Customers, employees, investors and others are demanding greater and faster action, and legislation is quickly changing to ensure organisations truly manage climate risk and adopt sustainable practices.
- "In 2022, we opened the survey again, with one additional 'spotlight section' on 'reporting readiness'. Overall the findings from the 2022 survey reinforce 2021 insights and the need to progress from 2021. This result is surprising given the increased emphasis on sustainability. The survey reconfirmed most organisations and CFOs have begun their journeys, but there are opportunities for CFOs to accelerate their impact and pace of change.

"CFOs are able to identify barriers to progression, but addressing them is the difficult part. This year, we urge CFOs to lead their organisations by focusing on the material issues and to look outwards to partners your organisation can collaborate with for positive sustainable outcomes.

"We hope both the survey itself and this snapshot report emphasise the unique role and value of the CFO in driving sustainability action - and encourage CFOs to pause, celebrate progress to date, reflect on their role and contributions and continue their journeys forward.

One year of Wildfires Undid Decades of **California's Emissions Policy**

- "The visible physical damage wrought by forest fires is plain to see. But they have a further, invisible cost which is not as frequently quantified as the number of lives and value of properties lost. Trees and other vegetation extract carbon from the air. When they go up in flames, the carbon stored within their woody cells combines with oxygen to once more form carbon dioxide – adding to the environmental toll of the fires. 'Dust to dust', the saying goes. For trees, it is 'gas to gas'.
- "This cycle means raging wildfires are a considerable and often ignored source of emissions, and a growing one, too. In California, according to a new analysis published in Environmental Pollution, a journal, wildfire emissions are estimated to have wiped out the benefits of more than a decade of efforts to reduce emissions from energy, homes, waste, transport and industry (see chart).

Fair Chance for all: Breaking the Cycle of Persistent Disadvantage

"The Government has asked the Productivity Commission to undertake an inquiry into economic inclusion and social mobility – A fair chance for all – with a focus on helping those experiencing persistent disadvantage. This report brings together our interim findings on this wide-ranging and complex topic and seeks public comment and feedback on a way forward.

- "We all want to live fulfilling lives where we have a strong sense of identity, are able to contribute to our families and communities, have the things we need to realise our aspirations, and grow the next generation of New Zealanders. As New Zealanders, justice and caring for others is part of our cultural identity. We all share a responsibility for looking out for each other and not leaving anyone behind.
- "While many of us are thriving, there are too many in New Zealand who are not. About 17% (724 000) of New Zealanders experienced persistent disadvantage in both 2013 and 2018. Young people, families and whanau can face multiple disadvantages which hold them back, which can turn into a cycle of persistent or intergenerational disadvantage. People and families face impossible choices every day, just trying to get by.....

"To address the barriers, we propose further changes are needed to the design and operation of our public management system.

"While reforms in discrete areas of policy, such as those in the health sector, show promise for making a difference, we believe more fundamental change to the 'macro'-level settings of the public management system is required.

"We characterise the system shifts which are needed as to:

- Re-think overall system settings to prioritise equity, wellbeing and social inclusion ...
- Re-focus public accountability settings to activate a ٠ wellbeing approach
- Broaden and embed a wellbeing approach across policymaking and funding frameworks
- Enable system learning and improvement through monitoring and evaluation
