TNFD Releases Final Beta Framework

"The Taskforce on Nature-related Financial Disclosures (TNFD) released [29th March] its fourth and final beta framework for nature-related risk management and disclosure with the TNFD on track to publish its final recommendations in September 2023. For the first time, market participants can view a full representation of the framework, including the Taskforce's proposed approach to disclosure metrics.

"Since the start of its work in October 2021, the TNFD's open and iterative approach to the design and development of the framework has garnered the support of over 1,000 organisations of the TNFD Forum, and 200 organisations now pilot testing aspects of the draft framework around the world and across sectors. The draft framework, available on the TNFD website, has been viewed over 90,000 times from market participants across more than 150 countries and

"Feedback from market participants and other stakeholders has broadly endorsed the three core elements of the draft framework:

"Like the TCFD, the TNFD is developing a global framework for risk management and disclosure, not a standard. The final draft draws from, and is designed to inform, relevant standards including those from the International Sustainability Standards Board (ISSB) and the Global Reporting Initiative (GRI), both knowledge partners to the TNFD

"Following a final 60-day consultation process, from 30th March to 1st June 2023, the TNFD's final recommendations based on final feedback and pilot testing (v1.0) will be published in September 2023. ...

Right to a Healthy Environment; Pushback from US, Some Abstentions

"The UN Human Rights Council has encouraged governments to adopt policies and an effective legal framework to implement the right to a healthy environment, a resolution that sparked tensions between proponent countries and the

"The resolution passed today [4th April], led by Costa Rica, the Maldives, Morocco, Slovenia, and Switzerland, reaffirms the human right to a clean, healthy and sustainable environment and called on states to protect environmental defenders trying to uphold it. It also calls on UN treaty bodies to promote its implementation.

"John Knox, professor of international law at Wake Forest University School of Law and the UN's former special rapporteur on human rights and the environment, said it marks a turning point from recognising the right 'to actually starting to take steps to implement it'

"It identifies concrete steps to make this right a reality, beginning with protecting environmental defenders and communities facing the deadly impacts of the ongoing triple planetary crisis', agreed Sébastien Duyck, human rights and climate campaign manager at the Center for International Environmental Law.....

Insurer Quits Climate Alliance; Legal Fears

- 'German insurer Munich Re said on Friday [31st March] it was withdrawing from an industry-wide alliance of insurers focused on reducing carbon emissions, a blow to the group from a prominent founding member.
- "Munich Re, the world's largest reinsurer, pledged to stick to its own climate targets but said it would exit the Net-Zero Insurance Alliance to avoid antitrust risks.
- "Antitrust concerns are at the centre of a growing sustainability backlash in the United States, as Republican politicians push back on group efforts linked to climate and other so-called ESG issues.
- "There are no known cases of a company targeted by an antitrust lawsuit over its policies, but actions by some Republican politicians in the United States have made many financial firms wary of that risk.
- "The world's second-largest fund manager Vanguard in December pulled out of a similar alliance for the industry.
- "It is more effective to pursue our climate ambition to reduce global warming individually', said Joachim Wenning, CEO of Munich Re.
- "The UN-convened alliance's website says it is a group of 30 insurers and reinsurers, including Allianz and Axa, which collectively represent about 15% of world insurance premium volume globally.
- "Munich Re was a founding member of the alliance, which was established in 2021.

- Single-use plastic produce bags
- Single-use plastic drinking straws
- Single-use plastic tableware and cutlery
- Plastic produce labels

All other PVC and polystyrene food and drink packaging to be phased out from mid-2025

UN Water Conference Needs to Kickstart a Revolution

- "The UN 2023 Water Conference from two weeks ago [as of 4th April] was a long time coming. It had been 46 years to be precise since world leaders gathered in Mar del Plata to discuss concerns about water. One of the central observations from the 1977 conference was 'the conservation and rational use of water resources is an unavoidable responsibility.'
- "Fast forward half a century and the weight of that responsibility could not be felt more acutely. The world has not valued freshwater in the intervening years, and to the contrary water stress is now experienced by billions of people across all continents.
- "The 2023 conference in New York should represent a launch pad for stronger collective action on the water crisis. However, only 12 heads of state turned up in person, favouring instead to send their environment ministers. There was also no negotiated agreement, no horse-trading between member states, no gavel coming down to signal the moment a historic deal was signed.
- "In its place, the main outcome was the Water Action Agenda a set of voluntary commitments made by governments, businesses, investors, and more, to value water. The final total of commitments reached 600 by the end of the conference, an important first step which showed the strength of feeling across the global economy. But these commitments need to be supported by a strong regulatory environment which only governments can create.
- "Another recommendation from the Global Commission, we need to mandate water disclosure to accelerate action and ensure a level playing field across the economy. It was encouraging to see the European Commission and the Government of Singapore intervene to call for mandatory water disclosure during the conference.
- "Water is a global commons and its depletion has significant knock-on effects for nature, climate, food, energy, and our economic health. Many member states are starting to realise this fact. What's needed now are strategies which reflect this interdependence.

Everyone is Accountable

"Earth Day is the perfect time to consider the growing risks to the planet and to us all, and to plan for a better future.

"On 22nd April, a billion people in 193 countries will commemorate Earth Day. It's been observed for more than 50 years to highlight threats to the environment and demonstrate support for environmental protections. At first Earth Day focused on pollution, but in recent years this has shifted to climate change and biodiversity. The aim is to engage governments, institutions, businesses and people worldwide on taking action: 'Everyone accounted for, everyone accountable'.

"Small-to-medium size enterprises comprise 97% of all Kiwi businesses and 98% of all Australian businesses. While they may not be the biggest emitters individually, collectively the International Federation of Accountants (IFAC) estimates SMEs generate 60–70% of all industrial emissions. So, any climate action they take can have a huge impact. ...

"While challenges are significant, there are many practical steps CAs can take to act on climate change:

- Learn about the issues, solutions and our roles in
- Think globally, act locally. Huge changes are needed worldwide, but they start in our own companies and communities.
- Measure, starting with the carbon footprint of our own businesses, to build knowledge and understand the challenges that others might have.
- Plan to halve greenhouse gas emissions by 2030 and to reach net zero by 2050. This applies in our own lives – in the businesses where we work.
- Don't rely too much on carbon offsets (the use of emission reductions or carbon storage elsewhere, such as planting trees) to offset business emissions. Offsets may be useful as an interim measure,
- Promote collaboration, with supply chains, industry or professional bodies and customers.
- Start now, even if you're not quite ready. ...
- Report on progress, as well as failures.

"New Zealand's Parliament passed the Organic Products and Production Act, on Thursday 30th March 2023, signalling the end of ten years work and the beginning of a new period which will enable the organic sector in Aotearoa New Zealand to flourish and prosper.

"The term organic is now protected. This means investments to help construct a future which makes a positive contribution to New Zealand's economy and wider environment now have greater assurance and security. It marks a great opportunity to simultaneously 'get in behind' farmers, sequester carbon, enhance biodiversity, make farming fun again and tap into the world's fastest growing multi food-food sector.'

Unheralded Environmentalist: Jimmy Carter's Green Legacy

"Pulitzer Prize-winning biographer Kai Bird reflects on the environmental legacy of Jimmy Carter, who is now in hospice care. Like much about his presidency, Bird writes, Carter's environmental initiatives have been largely underappreciated.

"He oversaw the largest single expansion of protected lands in U.S. history, released a prophetic report on climate change, and set a goal of sourcing 20% of the nation's energy from renewables by 2000.

"Carter was always annoyed when pundits proclaimed him a 'model' ex-president, but a failed president'. Bird writes. 'And he was right to be annoyed because his was actually a quite consequential presidency, and no more so than on questions of conservation and the environment.'

"Globally, the threat to nature (particularly biodiversity loss) is an emerging crisis – one that has the potential to outstrip the impact of the climate crisis.
