'Obsession' with Economic Growth **Condemned by Irish President**

"President Michael D Higgins has condemned the 'obsession' with achieving economic growth in a speech on Friday [28th April 2023] which was implicitly critical of the economic policies pursued by successive governments.

"In a reception at Áras an Uachtaráin for Tasc, a think tank dedicated to social change, the President delivered a typically wide-ranging speech which featured a strong critique of economic policy which seeks to prioritise growth, a condemnation of 'neoliberalism' and an evaluation of the shortcomings of the teaching of economics at universities.

"He also urged those present to 'envisage our future utopia', suggesting the Ireland must "rebalance economy, ecology and ethics".

"Many economists remain stuck in an inexorable growth narrative, or at best a 'green growth' narrative', he said. 'A fixation on a narrowly defined efficiency, productivity, perpetual growth has resulted in a discipline which has become blinkered to the ecological challenge – the ecological catastrophe – we now face.

"That narrow focus constitutes an empty economics which has lost touch with everything meaningful, a social science which no longer is connected, or even attempts to be connected, with the social issues and objectives for which it was developed over centuries. It is incapable of offering solutions to glaring inadequacies of provision as to public needs, devoid of vision.'

Banking on Climate Chaos

"The 2015 Paris Climate Agreement was considered a historic breakthrough in putting the world on a trajectory to limit global warming to no more than 1.5°C, the level scientists say is required to prevent irreversible climate chaos.

"Yet since then, the world's 60 largest banks have ploughed \$5.5 trillion into fossil-fuel financing, including expansion projects, tar sands oil, Arctic and Amazon oil and gas, offshore drilling, fracking, liquified natural gas, and coal mining, according to the 2023 Banking on Climate Chaos report.

A Common Talking Point About Climate Change Gets It All Wrong, New Study Says

"There's no solid evidence that framing the global problem as a local one prompts people to act. So, what does?

"Common wisdom says the average person doesn't care about climate change because they think its effects will unfold in the far-off future or in faraway places. So, to get them to do something, you have to make those effects – the floods, the heat, the fires – feel immediate and personal. This point is repeated ad infinitum in tips about how to talk about the climate crisis, in books, articles, and guides for public officials.

"While this approach feels right, its success has been 'vastly overestimated', according to a study published in the journal One Earth on Friday. Researchers in the Netherlands surveyed 30 studies to see if emphasizing climate change as a pressing, localised problem would motivate people to support environmental policies, donate to environmental organisations, or switch to lower-carbon practices like cutting down on driving. More than 80% of these studies failed to find evidence the strategy worked.

"One problem? The tactic's premise is misplaced: According to international polls, most people already believe they're seeing the results of climate change where they live, or at least will soon.

"Spreading messages which say the opposite – that people think of it as a distant threat – could backfire, said Anne van Valkengoed, a co-author of the paper and a postdoctoral researcher studying environmental psychology at the University of Groningen. If people think other people think it isn't a pressing problem, they may be less likely to take action themselves, whether putting solar panels on their home or calling up their elected representatives. It's simply a matter of fitting in.....

"The study recommends researchers, communicators, and officials start talking more about 'the finding many people already perceive climate change as occurring here and now', leveraging popular support to accelerate the shift to a lowercarbon world. 'You want to give people the sense they're not alone in combating climate change', van Valkengoed said. 'It's something a lot of people actually care about.'

For Farming, is Net Zero Ambitious Enough?

"Lake Hāwea Station, a New Zealand sheep and beef farm, demonstrates how being carbon positive can also be profitable.

"With the world facing climate catastrophe, is it enough for businesses in well-off areas to be carbon neutral? Agriculture is a major source of greenhouse gases, producing around 18% of global emissions. As a proportion it's lower in Australia, around 13%, dwarfed by energy production. But in New Zealand a massive 50% of emissions come from agriculture - most of this as methane, belched by grasseating livestock.

"The owners of Lake Hawea Station, a large sheep and beef farm in New Zealand's South Island, believe farming, rather than contributing to the climate crisis, can be part of the solution. Not only that, but the journey to being climate positive can bring financial benefits – as well as for nature, for future generations and for the planet.

"Well done, but is it enough? Carbon neutrality, the family decided, is 'insufficiently ambitious'; the goal is to be 10 times carbon positive. And there's a plan to achieve this through protecting vegetation, planting 10,000 trees a year, electrification, reduction of methane emissions through use of seaweed, genetics and restoring soils.

"Justine adds, 'We've got eight years left to meet our national climate targets and we want to do our bit and influence change. To sequester more carbon than we emit is the single biggest koha [gift] we can make to the world.'

"The farming sector faces some major challenges, including the risks of irreversible climate change and loss of biodiversity. It is heartening to know a farm can be climate positive, can protect and enhance biodiversity, and succeed financially as well. This really might set an example – to other farmers in Aotearoa, Australia and further afield. And that would be positive for us all.

Naming NZ Butterfly Species

"Ninety-three percent of New Zealand's native butterflies and moths are unique to Aotearoa! They are found nowhere else in the world – and if they die out, they can never be reintroduced.

"The family of copper butterflies is a great example. They are native to NZ whereas the monarch and cabbage white butterflies are not.

"Some native butterflies are already teetering on the edge of survival', said Brian Patrick, the MBNZT's Biodiversity Advisor. 'There's a tiny purple copper butterfly which now exists only in one coastal carpark in the South Island. It needs our protection - but firstly it needs to be identified!'

"We all need our butterflies to thrive so they can continue their important work as pollinators, food for birds and to brighten our summers.

"Sadly, successive governments have invested too little in research and taxonomy, the naming of species', said Angela Moon-Jones, who is spearheading a campaign to save our NZ butterflies. 'We are far behind most other countries.'

"We need the support of caring New Zealanders now to save our precious butterflies.'

Coconut Coir Helping Stop Coastal Erosion

"Along South Riverside Drive in Neptune, New Jersey, until last fall, at high tide on the Shark River, water almost lapped the edge of the road, yards away from a row of houses.

"To strengthen the shoreline, the organisation led a project to build up the riverside dune and expand and raise the beach with new sand. To encourage marsh vegetation to grow at the water's edge, teams also installed shaggy logs made of a fibre that you're more likely to see in Bali than along the Jersey Shore: shredded coconut husk.

"Coir, as the material is known, is a common ingredient in an approach to combating coastal erosion through habitat restoration. An increasingly popular alternative to hard barriers like concrete bulkheads, these so-called 'living shorelines' utilise natural elements like rocks, reefs and plants to fortify the shore against erosion. Biodegradable yet sturdy, coconut fibre frequently plays a role as a temporary buffer which can help build up soil layers and give vegetation a stable place to take root.

The Climate King: King Charles' Influence Over the Hearts & Minds of Business Leaders

"In 1971, aged just 21, the then-Prince of Wales used his first public speech to raise concerns about planetary degradation. While many of the claims were met with scepticism back then, his concerns about river pollution, air pollution and plastic use could be repeated verbatim today with little need for revision.

"Since then, King Charles III's views have remained consistent; he has continued to be a powerful advocate for tackling the challenges our planet is facing. The new monarch has a certified history of promoting better outcomes for our planet, tackling deforestation in the Global South via the successful Prince's Rainforest Project and launching the Sustainable Markets Initiative (SMI) in 2020.[And more.]

Leading UK Lawyers Refusing to Work for Fossil-fuel Clients

"In March two UK activists, Morgan Trowland and Marcus Decker, were jailed for climbing the Queen Elizabeth II bridge over the River Thames and causing huge traffic disruption as part of a Just Stop Oil protest last year.

"The pair were jailed for three years and two years seven months, respectively, with Judge Collery KC making it clear that the tough sentences were designed to deter copycat protests. Just Stop Oil described the punishment as draconian.

"The decision came a month after one of the rocks on which the British legal system rests, the cab rank rule, was called into question by a group called Lawyers Are Responsible.

"Although barristers – with one or two exceptions – are dutybound to take the next brief they are offered, 120 leading lawyers (the figure has since risen to 160) launched a 'declaration of conscience', saying they would refuse to act for new fossil fuel projects or prosecute anti-fossil fuel campaigners.

"None of these fossil-fuel projects would come into being without lawyers to act as midwives', says Jolyon Maugham, director of the Good Law Project and a signatory of the declaration.

"In the United States the Law Students for Climate Accountability has estimated that since 2017, leading law firms globally have facilitated \$1.63 trillion in fossil fuel transactions. The group, whose goal is to force the legal profession to face up to its role in exacerbating climate change, has produced a climate change scorecard on the 100 top law firms in the U.S., and is set to launch a similar report on UK firms later this month.

"If law firms can be criticised for doing this work which is destroying the planet, it will be much, much more difficult for them to recruit young people," adds Maugham of the Good Law Project.

"Big 4" Australian Banks **Financing Destruction**

"Environmental lobby group Friends of the Earth (FoE) says Australia's largest banks are helping destroy Queensland's Great Barrier Reef by funding the mining and gas industry.

"Market Forces, a part of FoE, claims that since 2008 the 'big four' banks have lent \$3.8 billion to coal port owners and gas extraction firms that operate inside the World Heritage listed Great Barrier Reef area.

ANZ has lent \$1.1 billion, the Commonwealth Bank [owners of ASB Bank] \$1 billion, Westpac \$905 million and NAB \$791 million, the group says.

"..... ANZ Bank says the institution is working with clients to help reduce carbon emissions.

"...... wants the banks to rule out funding new coal and gas export projects that may damage the reef.

"He says the dredging of sand to expand ports and an increase in the number of ships crossing the UNESCO World Heritage Area with mining products put the reef at risk.

"Mr Vincent said the use of coal worldwide also contributes to climate change. 'Australians rightly care about the Great Barrier Reef and want to see it protected,' he said. 'It is unacceptable for the big banks to use Australians' money to bankroll projects that are threatening the reef.'

"An ANZ spokesman said the bank was helping its clients reduce emissions as the nation shifted to a low carbon economy. 'We have a commitment to increase our project lending to renewable and gas-powered energy by 15-20% by 2020. This builds on our existing portfolio of which renewable technologies represent Sustainable Farming - Lifting a third of our total funding for power generation projects.'

"AAP says comment has been sought from the Commonwealth Bank, Westpac and NAB.

"UNESCO has said it will decide in the next few months if the Great Barrier Reef should be listed as a World Heritage site in danger, due to the rapid increase in coastal developments.

What Is an Environmental Issue?

- "I believe that understanding this question is central to our choice to exist. The majority of us understand an environmental issue as a weather event or natural disaster that creates uncomfortable conditions for us. On a small scale we analyse these impacts on a daily basis. 'It snowed in Manhattan this morning - will my train be delayed?' 'It hasn't rained for a week, will I be able to water my crops?'
- "Less often do we consider how our behaviours might negatively affect the environment. This is a bit of an oversight on our part. For example, there were 5 billion mobile subscriptions The reality is that nature's behaviour will always have consequence for us – ultimately, our species is utterly dependent upon nature. The reverse is not true: the planet will go on, with or without us. What remains to be seen, is how long conditions here will remain hospitable to our existence.
- "I have harangued audiences in the past with my belief that the question 'can we sustain ourselves?' is in fact a banal inquiry. We have no choice but to be sustainable if we want to survive. No species can exceed its range, particularly one so committed to destroying its range. There is no survival without sustainability; unsustainability leads, unavoidably, to extinction. The choice we do have is between whether we become more sustainable with a sense of grace and compassion or whether we induce rapid systems collapse through rapacious consumption and degradation of the global commons.
- "We, as a species, particularly in the industrialised world seem intent on shooting ourselves in the collective human foot by psychologically removing ourselves from nature. Nature has become 'the other', the 'environmental issue', rather than us. This simple fact makes it impossible for us to make reasoned decisions about how we live and how we consume resources. The warning lights are blinking in several countries where the struggle to survive and prosper is no longer an economic issue but rather an increasingly violent struggle for essential resources like land and water.
- "Back in my city planning days I used to talk about the battle over pronouns. All the thorny issues were set up as struggles between the pronouns 'I', 'we' and 'they'. While almost every conflict was phrased as 'I' versus 'they', solutions were possible only when the idea 'we' gained currency. The relationship between society and the environment in industrialised cultures has become an 'it' issue. You can see it in the language. Nature is not understood as a shared context for supporting life but rather has become another form of capital. We've even cast natural phenomena in villainous roles like 'killer, cruel, devastating, crushing', as though our existential concerns were something for nature to care about.
- "In the brief space of a century or two we have applied our ingenious technologies to live more comfortably in uncomfortable places. We've drained wetlands to build houses by the beach, air conditioned whole cities so we can live comfortably in the desert, cleared forests to build coastal metropolises. We have consumed vast resources to do so, and we require vast resources to maintain status quo. Growth requires adding ever more energy. So we have created our own paradox. The cumulative effects of the interventions that allow us to live comfortably are exacerbating the very conditions we are attempting to overcome. In other words, it is becoming increasingly uncomfortable to live in the places where we've grown comfortable living.....

"Humanity is not going to win a fight with nature. But humility may allow us to coexist.

The Australasian Centre for Corporate Responsibility

"The Australasian Centre for Corporate Responsibility (ACCR) is to be launched in Canberra on 29th May 2013. ACCR is a not-for-profit association whose mission is **to promote ethical investment**. Particularly, they facilitate **informed shareholder engagement and advocacy** to promote just and sustainable corporate activity.

"One of the ACCR's goals is to improve company behaviour and performance concerning environmental, social and governance issues. To achieve these changes it is necessary first to generate information regarding corporate activity and then to engage in dialogue with selected companies. If this dialogue is not effective, the next step may be to request that a company distribute a statement to all its shareholders about a particular concern. Alternatively shareholders might request that a resolution be placed at its AGM for consideration.

Thus, the term 'shareholder advocacy' encompasses three activities:

- 'Engagement' which includes dialogue with the company and communication with other shareholders to seek their support
- 'Filing of resolutions' which request a company place a resolution on its AGM agenda
- 'Proxy or electronic voting or physical presence at a meeting' in order to support resolutions or desirable candidates who seek election or re-election as directors.

"The Social Progress Imperative's mission is to advance global human wellbeing, by combining national social performance and capacity indicators with solutions-oriented outreach to sector leaders, and grassroots champions, who together can effect large-scale change. Social progress is defined as the capacity of a society to meet the basic human needs of its citizens, establish the building blocks that allow citizens and communities to enhance and sustain the quality of their lives, and create the conditions for all individuals to reach their full potential.

"The first major effort of the Social Progress Imperative is the Social Progress Index, launched 11th April 2013 at the Skoll World Forum in Oxford, UK. The Social Progress Index is a tool that we hope will be widely used to inform and influence policies and institutions around the world. The Index is founded on the principle that what we measure guides the choices we make. By measuring the things that really matter to people – their basic needs, their food, shelter and security; their access to healthcare, education, and a healthy environment; their opportunity to improve their live – the Social Progress Index is an attempt to reshape the debate about development......

- "Paul Gilding, an international business adviser, author and speaker, will headline a series of seminars being held around the country this month.
- "The Fonterra Shareholders' Council said its '*Grow Your Minds'* seminars were designed to give farmers a better understanding of current sustainability and commercial issues.
- "We want to be leaders in this space and in order for this to happen it is important our farmers see the value in sustainable practices," said chairman Ian Brown.
- "It was also important for farmers to hear views from outside the Fonterra Co-Operative, Brown said.
- "Gilding, who served as executive director for Greenpeace International in the early 1990s, said Kiwi dairy farmers must embrace sustainable farming practices if they wanted to keep a strong foot in the market.
- "Demand from both general consumers and major corporates like Unilever was heading in one direction towards sustainably produced dairy products, he said.
- "The point of my speaking tour is to say, 'This is going to happen in the global market and if you want to hand on a healthy farming business to your kids, you need to embrace the future in this way'.

A Climate Change's Maths Lesson that Might Just Change the World: DO THE + MATHS TOUR

"It's simple maths: we can burn less than **565** more gigatons of carbon dioxide and stay below **2°C of warming** – anything more than that risks catastrophe for life on earth. The only problem? Fossil fuel corporations now have **2,795 gigatons** in their reserves, five times the safe amount. And they're planning to burn it all – unless we do the maths to change our future.

"In November 2012, Bill McKibben and 350.org hit the road in the USA to build a movement strong enough to change the maths of the climate crisis. The *Do the Math Tour* was a massive success, with sold out shows in every corner of the US.

- "Australian coalmining has become a 'rogue industry" and most of the coal slated for export must stay in the ground if the nation is to tackle climate change, according to prominent US environmentalist Bill McKibben.
- "Many coal projects, and coal infrastructure projects in Queensland, are expected to run for decades, and are only now gaining development approval.
- "But the federal government has pledged to reduce Australia's greenhouse output by 80% by the middle of the century, putting it on a collision course with the resources expansion.
- "If the world ever takes climate change seriously, that coal simply has to stay in the ground', Mr McKibben said. 'There's no physical way to burn it, or Canada's tar sands, or Venezuela's shale oil, and not go over the red line that almost all governments, including Australia's, have drawn at two degrees'.
- "Australian-mined coal burned overseas generates about 711 million tonnes of carbon dioxide a year, but when new mines are taken into account, that total will be up to 1431 million tonnes in 2020, and 1738 million tonnes in 2025.
- "Mr McKibben, the author of the first mainstream book about global warming, *The End of Nature*, will visit Australia [and NZ] in June to galvanise local campaigns for action against climate change. He is travelling to Australia with 350.org, the group he helped found in 2008.....
