Building a Wellbeing Economy from the City Up

- "The role of cities in creating an economy fit for the 21st century.
- "Can the economy be redesigned with the purpose of serving the wellbeing of people and the planet first and foremost? Around the world business leaders, government agencies, and citizens are moving beyond the focus of Gross Domestic Product (GDP) and economic growth as being the primary markers of success and are instead shifting their thinking towards other indicators that could contribute to a healthy economy.
- "International expert Dr Katherine Trebeck discusses why a wellbeing approach to measuring success and progress for the economy is gaining momentum and what it looks like in practice. Drawing on insights from overseas, Dr Trebeck examines what various sectors can do to help build a wellbeing economy. She shares some examples of actions other cities have been taking which demonstrate what a wellbeing economy means at the city-level and discusses the implications and benefits this approach could bring.

The Upper Atmosphere Is Cooling, Prompting New Climate Concerns

- "Contributing writer Fred Pearce reports on new research which finds our carbon emissions are not only warming the lower atmosphere but cooling the upper atmosphere. Satellite data reveal that between 2002 and 2019, parts of the upper atmosphere cooled by 1.7°C, and researchers estimate temperatures there could drop by 7.5°C by the end of this century.
- "The dramatic changes aloft are fueling concerns about the effects this cooling could have on the ozone layer and its potential to create turmoil with the weather on Earth. Increases in CO2 are now 'manifest throughout the entire perceptible atmosphere', one physicist says, which is 'driving dramatic changes scientists are just now beginning to grasp.'

Climate investment in Aotearoa

- "This brief paper, intended for attendees at the April 2023 *Investing in Climate Solutions* conference convened by several Community Trusts, Philanthropy New Zealand, Tōpūtanga Tuku Aroha o Aotearoa and Toitū Tahua, the Centre for Sustainable Finance. It provides an outline of the climate investment landscape which may assist attendees[and others].
- "We understand attendees may include Non-Government Organisations and philanthropic investors who wish to do more to address climate change, as well as their advisers.
- "The following pages show a number of climate impact investment options, whether aiming for investment returns or impact benefits, or a combination of both. They consider the following:
 - What level of Climate Impact may be expected from this form of investment?
 - What level of Potential Returns may be expected?
 - Is it a form of climate change 'Mitigation' (reducing emissions, so climate change has a reduced impact) or 'Adaptation' (dealing with the consequences and impacts of climate change) – or both?
 - Is it a kind of Investment or Granting or possibly both?
 - Is it a form of Equity or Debt or possibly both?
- "This is not intended to be an exhaustive or definitive list. It provides more detail on mitigation solutions as these are generally more developed; more detail may be added on climate adaptation solutions in future versions of this document.

This Foldable Coffee Cup Wants Us to Ditch Plastic Lids for Good

- "Single-use plastics are finally starting to disappear from the market, as countries like Canada, China, India, Japan, and more implement single-use plastic bans and regulations.
- "But humans still crave their to-go orders and morning coffee, and sometimes you just forget to grab the travel mug on the way out the door.
- "The Good Cup is a foldable, recyclable vessel which acts as a mini takeout container for hot and cold drinks.
- "The cup eliminates the need for a separate lid, as the folding design features a notch that locks into place to maintain that on-the-go reliability without crowding landfills.
- "The Good Cup is fully recyclable and re-pulpable, made with compostable paper and recyclable bio-based coating. It can be composted at home or sent to recycling facilities – where the paper can be recycled up to seven times before heading back to the Earth....

#NoFly: Walking the Talk on Climate Change

- "In June 2018, Swede Maja Rosén founded "We stay on the ground" with a pledge not to fly in 2019, and a goal of persuading 100,000 other Swedes to join her. In August, her compatriot Greta Thunberg began her school strike for climate.
- "Today, the No Fly movement has spread around the world, with the Flight Free 2020 campaign reaching eight countries, and Greta is a household name, with the September strikes drawing 4 million people globally. What a difference a year makes!
- "The New Zealand scientist Shaun Hendy made his own flightfree year in 2018, attracting widespread publicity in the media, partly thanks to Stuff's 'Quick! Save the Planet' series. In #NoFly he describes why he made the pledge, how it worked out, and how he sees New Zealand's lowcarbon future playing out.
- "Shaun credits University of Auckland psychology professor Quentin Atkinson for giving him the push he needed. The theory of 'costly signalling' says people can better send honest signals about themselves if their message is accompanied by taking some action which requires effort. (Philanthropy, risk-taking, and conspicuous consumption are the classic examples.) Indeed, psychological studies have found, not surprisingly, who people strongly dislike hypocrisy and regard hypocrites as untrustworthy (whereas lying, strangely enough, is all right).

When purchasers globally is asking for sustainable criteria, the signal to the IT industry sets the process in motion, which the number of new certified products is showing.
- "As many as 122 new product models were certified during March. A new all-time high in a separate month since the launch month of TCO Certified, generation 9. The 122 product models come from ten different brand owners. Displays and notebooks are the most popular product categories, followed by desktop computers and headsets. In total, there are now around 4,000 products certified according to TCO Certified

CA ANZ launches Carbon Accounting FAQ's

- "A new Chartered Accountants Australia and New Zealand (CA ANZ) publication addresses frequently asked questions (FAQs) arising in the evolving area of carbon accounting, and links to practical resources to assist climate-related accounting activities.
- "Carbon and climate-related accounting practice is evolving fast. Approaches and terminology are rapidly changing, as are the aspirations and expectations of accountants applying their accounting skills and experience to climate-related issues.
- "As accountants tackle carbon accounting and the many varied and evolving approaches and terminologies, this has prompted them to ask many questions. To address these, and contribute to the carbon accounting community of practice, CA ANZ has published a set of FAQs.
- "Members are asking us all sorts of questions connected to carbon accounting; from 'how do I account for carbon offsets', 'what's the difference between net zero and carbon neutral' to 'what are my obligations to prevent greenwashing and everything in between' says Karen McWilliams FCA, CA ANZ Sustainability and Business Reform Leader. 'While often there aren't definitive answers, in these FAQs we explain the issue and where relevant link members to practical resources
- and the carbon accounting landscape.

Turning Off the Tap: How the World Can End Plastic Pollution and Create a Circular Economy

- "The report proposes a systems change to address the causes of plastic pollution, combining reducing problematic and unnecessary plastic use with a market transformation towards circularity in plastics. This can be achieved by accelerating three key shifts – reuse, recycle, and reorient and diversify – and actions to deal with the legacy of plastic pollution.
- "Reuse refers to the transformation of the 'throwaway economy' to a 'reuse society' where reusing plastic products makes more economic sense than throwing them away. The report highlights the importance of accelerating the recycling market for plastic recycling by ensuring that recycling becomes a more profitable venture.
- "Reorient and diversify refers to shifting the market towards sustainable plastic alternatives, which will require a shift in consumer demand, regulatory frameworks and costs.

"The report highlights these solutions are available now and a systems change, underpinned by the necessary regulatory instruments, will result in a range of economic benefits and reduce damage to human health, the environment and the climate.

Govt Taken to Court for Ignoring Climate Commission on ETS

"The [New Zealand] High Court has been asked to overturn a Cabinet decision to artificially deflate the price of carbon because it went against the advice of the Climate Change Commission.

"The climate-concerned lawyers behind a previous major legal action against the Government and the Commission filed a new statement of claim on Tuesday [16th May], this time targeting Climate Change Minister James Shaw. Lawyers for Climate Action (LCANZI) says Cabinet's decision to reject the advice of the commission on price controls in the Emissions Trading Scheme (ETS) violated the Zero Carbon Act's requirements.

"While Shaw recommended following the commission's settings in full, Cabinet overrode him in a late November meeting due to concerns about the impact of a rising carbon price on the cost of living. As the climate minister, it was ultimately Shaw's responsibility to carry out Cabinet's decision.

"In its advice last month on future ETS settings, the commission scolded the Government for ignoring its advice.

- "Weakening decisions on NZ ETS settings and climate policy in general during times of adverse economic conditions, which climate change is only likely to exacerbate, is not sustainable in the long run and will greatly compromise our chance of meeting the climate change targets set out in the act', Carr wrote.
- "At the time, climate policy expert Christina Hood said the harsh language in the report was the most critical the commission had been of a government decision.
- "This is much clearer and stronger than anything we've seen the Commission come out with before. It's a real shot across the bows', she said.
- "They obviously think the Government has made a mistake and are not pulling any punches in saying so.'
