2023 Earthshot Prize Winners Announced

"An agritech startup which helps female farmers in India to cut food waste using solar-powered dehydration equipment is among the five green innovations to scoop the Prince of Wales' prestigious Earthshot Prize.

"The winners of the annual eco-awards were revealed on Tuesday evening [7th November] at a star-studded ceremony at the Theatre at MediaCorp in Singapore.

"Each will walk away with £1 million to scale up their pioneering projects.

"Prince William and his Royal Foundation launched the ambitious 10-year initiative in 2020, with the goal of funding 50 solutions to some of the planet's most urgent environmental problems by 2030.

"I choose to believe future generations will look back on this decade as the point at which we globally took collective action for our planet – the moment we refused to accept the voices of denial and defeatism, and instead became the architects of change towards a healthy and sustainable world', William said during the ceremony.

"This year's winners were chosen from a shortlist of 15 finalists by Prince William and the Earthshot Prize Council, chaired by Christiana Figueres, a former UN climate chief, who played a key role in negotiating the Paris Climate Agreement in 2015. Other members of the judging panel include Queen Rania Al Abdullah of Jordan, activist Ernest Gibson and Alibaba founder Jack Ma among others.

"The competition is based around five 'Earthshots', or environmental goals. This year's winners are:

- Protect and Restore Nature: Acción Andina, from Peru.
 The grassroots project is working in South America to protect native forest ecosystems across the Andes.
- Clean Our Air: GRST, from Hong Kong. The start-up has developed a new process for making and recycling lithium-ion batteries, paving the way 'to make the electric cars of the future even cleaner.'
- Revive Our Oceans: WildAid Marine Program, a global organisation with US-based headquarters. The nonprofit combines 'partnership building and knowledge sharing' to support the planet's ocean conservation needs
- Build a Waste-Free World: S4S Technologies from India. The agritech start-up uses its solar-powered dehydration equipment to cut food waste and help farmers process excess crops into products with a longer shelf life.
- Fix Our Climate: Boomitra, a global organisation with US-based headquarters. The company is 'removing emissions and boosting farmer profits by incentivising land restoration' through the creation of its soil carbon marketplace.

Advances in Refrigeration at the Farm

"Purpose Capital Impact Fund has made a \$3m investment into Cool Group Ltd. Cool Group is a New Zealand-owned and operated company whose subsidiaries include: CoolSense NZ Ltd, Original Equipment Manufacturer (OEM) of commercial and industrial chilling systems; CoolCARE NZ Ltd, subscription-based remote data support service; and PAUS Rental Ltd, a freshly launched leasing model in partnership with Fonterra and New Zealand Green Investment Finance (NZGIF).

"Cool Group's chilling system use refrigerants with significantly lower Global Warming Potential (GWP) than existing systems (466 GWP vs up to 3,920 GWP). They also use much less refrigerant (7kg vs an average of 30kgs).

"In combination, the company estimates replacing one legacy system with a CoolSense system instantly removes an average of 90 Tonnes net CO2 equivalent from the average farm. Refrigerants removed from farms are safely destroyed and the scrap metals from the legacy machines are recycled. These changes are an important step in NZ's commitment to phase down hydrofluorocarbons (HFCs) over the coming years, in line with international obligations under the Kigali Amendment.

"Traditional systems also leak at an estimated 15% per annum while leakage of the CoolSense systems is estimated to be negligible due to the nature of the design.

"CoolSense products reduce energy consumption by approximately 30% compared with current products, saving the farm money and further reducing greenhouse gas emissions (depending on energy source). They also produce hot water as a by-product – a handy benefit for cleaning the milking shed. In addition, the chilling capabilities of the units means milk is snap chilled – benefiting milk processors by enabling higher value goods to be manufactured for global markets.

Study to Ascertain Capitals Approach Knowledge Gaps

"In 2022, Capitals Coalition launched their first free online course, Valuing Nature and People to Inform Decision-Making, followed in 2023 by Transforming Business: Valuing Social and Human Capital. Now, Capitals Coalition and two strategic advisors from INSEAD have conducted a study to measure the skills and knowledge gap in business professionals in sustainability and the capitals approach to transform decision-making.

"The study aimed to identify areas in which decision-makers need to invest in enhancing their team's skills. The research was conducted over two months through semi-structured interviews with 15 different organisations.

"Companies are facing many challenges as they move towards adoption, including a lack of understanding of integrated capital assessments, resource constraints, a focus on compliance, a lack of incentives, and data limitations. Interviewed companies struggled with understanding materiality and quantifying the impact of non-financial capitals on their businesses. Additionally, regulatory compliance took precedence over holistic, systematic assessments of capital impacts.

"These companies also found it challenging to prioritise and quantify material impacts.

"The results showed companies value training materials like case studies, data insights, and practical applications linked to mandatory disclosures. The training delivery models explored included train-the-trainer approaches (....) and direct-to-market strategies. Online training formats were preferred for maximum reach, focusing on simplicity and interaction. Continuous professional development (CPD) and accreditations were considered, emphasising collaboration with reputable institutions and transparent feedback from accredited participants.

"Six key recommendations

"Westpac's natural capital position statement, released today [6th November], sets new targets for the bank's loans to agriculture (defined as dairy, beef and sheep) and includes 'a commitment to no deforestation, which provides for no further conversion of natural forest to agricultural land use within farm systems from 31st December 2025 for customers in scope of the targets.'

"In addition to the zero-deforestation policy, Westpac has today:

- Further tightened its lending to new coal, oil and gas projects by including restrictions on bonds as well as loans.
- Released more detail on its expectation for all business customers to have a 1.5°-aligned transition plan, but has delayed the deadline by nine months to 30th September 2025.
- Linked a portion of its executive short-term bonuses to achieving climate targets.

"We would expect Westpac's decision to adopt a zerodeforestation policy for beef, dairy and sheep farming to drive a wave of zero-deforestation commitments across Australia's banking sector', said Jonathan Moylan, ACF's corporate campaigner.

"While global best practice is not to lend to businesses which have engaged in deforestation since the end of 2020, Westpac has given its agricultural customers until the end of 2025 to stop land-clearing, which could lead to panic clearing if adopted across the sector.

"While the scope of Westpac's commitment could be broader, it should help rein in Australia's unfortunate status as a global deforestation hotspot by focusing on the main driver of land clearing in Australia: pastoral expansion.

"Roof EZ president Jason Polly said in an interview the company's 'Roof and Gobble' promotion is for customers to protect their homes with a roof, bring their families together over a turkey and protect them with an AR-15.

The Behavioural Crisis Driving Ecological **Overshoot**

"As the world grapples with multiple ecological crises, it's clear the various responses over the past half century have largely failed. Our new research argues the priority now should be addressing the real driver of these crises – our own maladaptive behaviours.

"For at least five decades, scientists have worked to understand and document how human demands exceed Earth's regenerative capacity, causing 'ecological overshoot'.

"Those warnings of the threats posed by the overshoot's many symptoms, including climate change, were perhaps naive. They assumed people and governments would respond logically to existential threats by drastically changing behaviours.

"The young researchers in the 1970s who published the Limits to Growth computer models showed graphically what would happen over the next century if business-as-usual economic growth continued. Their models predicted the ecological and social disasters we are witnessing now.

"Once people saw the results of the research, the authors believed, they would understand the trajectory the world was on and reduce consumption accordingly. Instead, they saw their work dismissed and business-as-usual play out.

"Logically, the same behavioural strategies which fuelled consumerism can do the reverse and create the necessary desire for a stable state.

"Understanding the many dimensions of the behavioural crisis, including the influence of power structures and vested interests in a market economy, is crucial. Defusing and even co-opting those forces to reform the economy and reverse the damage is the challenge.

"It will require a concerted multi-disciplinary effort to identify the best ways to produce a rapid global adoption of new norms for consumption, reproduction and waste. The survival of complex life on Earth is the goal.
